CATEGORY 'B' Admissions

(Into MBA & MCA courses for the year 2013-2014)

It is hereby informed to the Managements of Private Unaided Minority & Non Minority MBA & MCA colleges that;

• The seats shall be filled following the rules of admissions prescribed in G.O.Ms.No.59, 66 & 67, 16 and guidelines issued in G.O.Ms.No.61.

Eligibility Criteria for Admission into CAT-B seats

- a) The Candidate should be an Indian National
- b) The candidate should have secured a rank at Common Entrance Test. The Candidates should have passed the qualifying examination i.e., Bachelor Degree of minimum three year duration with at least 50% marks (45% in case of candidates belonging to reserved categories) on the date of his/her counseling for admission into MBA Programme. The candidate should have passed the qualifying examination i.e Bachelor Degree of minimum three year duration with at-least 50% marks (45% marks in case of candidates belonging to reserved categories) on the date of his/her counseling along with Mathematics at 10+2 level for admission into MCA programme..
- c) NRI seats shall be filled with candidates who have passed the qualifying examination with not less than 50% of marks in aggregate or cumulative grade point average (CGPA) equivalent to 5 on a scale of 10.
- d) The left over seats shall be filled on the basis of rank obtained in ICET-2013 or on the basis of rank obtained in All India Common Entrance Test and should have secured not less than 50% of marks (45% in case of Reserved Categories) in the qualifying examination.
- e) The vacant seats, if any, may be filled with eligible candidates including those securing not less than 50% of marks aggregate/group in qualifying examination duly ensuring merit and transparency.

Procedure for Admission

- (i) The Managements of the Colleges shall notify the details of courses offered with intakes, schedule of admissions, cost of Application form and Minority/ Non Minority, status in popular news dailies one in each language i.e. English, Telugu & Urdu which is to be displayed on the College website and also on the college notice board.
- (ii) The blank application forms for admission in 'B' category seats shall be made available to the candidates from the college counter on payment of the prescribed fee. The facility for downloading the form of application from the college website should also be provided. In this case, the cost of procuring the application form shall be paid to the college by the applicant at the time of submission of the duly filled in application forms.
- (iii) The college authorities shall enter the day wise sale of applications with the name of the candidates and address in a Register opened for the purpose and it shall be made available for inspection for any Officer authorized by the Competent Authority.
- (iv) The college shall issue an acknowledgment / receipt for the applications received.
- (v) The Management shall prepare the merit list of eligible applicants for each course and announce the same by displaying both on the website and notice board of the college for at least two weeks from the date of announcement.
- (vi) The Institution shall obtain ratification from the Competent Authority for all the admissions conducted under Category B seats by the institution.
- (vii) The Management shall collect the Tuition fees as prescribed by AFRC for category 'B' seats.
- (viii) The Managements shall comply with the above instructions and failure in implementing the same shall entail withdrawal of Government permission, University affiliation and AICTE approval.

- 1. The Managements of MBA/MCA Colleges are informed that the Cut-Off date for submission of Admission lists for CAT-B seats is 21.10.2013.
